Training:

You must complete required training as stipulated in the Penal Code §§26165 and the course must be acceptable to the Tracy Police Department. Additionally, the training required must be supported by an approved certificate of completion. New applicants must complete a course which meets the requirements outlined in Penal Code §§26165(b). Renewal applicants must complete a course which meets the requirements of Penal Code §§26165(c).

A current list of acceptable course providers is available from the Tracy Police Department, upon request.

Notification of Confidentiality:

Applicant's information which is contained in the application for the CCW license may be subject to public access under the Public Records Act.

Note:

The Tracy Police Department recognizes your desire to be responsible and obedient of the law. Please be assured that your application will be thoroughly investigated and a license will be granted or denied based upon state law and the information provided. FEES: (These amounts are subject to change as permitted by law.)

Tracy Police Department would like to thank you for your interest in a "Carry Concealed Weapon" (CCW) permit. The attached application meets the requirements as set forth by the California Department of Justice.

It is the intent of Tracy Police Department to strictly adhere to the rules outlined by the Department of Justice (DOJ) and Penal Code §§26150 through 26225. Those rules are carefully outlined in the application packet.

All new and renewing applicants must submit a "CCW" Department of Justice Application which is available at the Tracy Police Department or on our web page. Please thoroughly read and complete the application. Illegible, incomplete, willful omissions or untruthfulness will cause your application to be rejected.

A voluntary but recommended review of your application is available to you by appointment through the Office of Professional Standards prior to submitting the application and paying fees. Fees are non-refundable.

Following are the requirements as stipulated in Penal Code §26150

Fingerprinting:

All new applicants are required to submit their fingerprints, via "Live Scan", to the Department of Justice for official clearance. For more information on "Live Scan" fingerprinting, go to <u>www.tracypd.com</u>.

Residency:

You must be a resident of the City of Tracy and show proof of such; i.e. Utility Billing, subscriptions, etc. These must be no older than 30 days. Post Office Box addresses are not residences and will not be accepted. A valid California Identification Card or Drivers License must also be presented. Proof of ownership of any weapon to be licensed must be provided. All applicants must be at least 21 years of age or older.

Good Moral Character:

You must be of "Good Moral Character"; No disqualifying law violations or convictions, no dishonorable discharge from military. You must submit three letters of character reference from persons other than family members.

Good Cause:

"Good Cause" is defined in the Attorney General Opinion 77/30 I.L. 1977 as "The issuing authority must determine whether the threat to the applicant (or other casual situation) is as real as the applicant asserts (e.g., is there a clear and present danger to the applicant, his spouse, his family or his employees).

On June 9, 2016 the Ninth Circuit U.S. Court of Appeal held, in *Peruta v. County of San Diego*, there is no constitutional right to carry a concealed weapon in public. As such, requiring one to state "good cause" when applying for a CCW permit does not violate the Second Amendment. Finally if the danger is manifest, the authority should determine whether that danger cannot be significantly alleviated by alternative means of security and whether the danger in fact can be lawfully mitigated by the applicant's obtaining a concealed weapon license." You must submit an attached letter outlining your "Good Cause" justification for your need to be issued a CCW.

Renewal applicants must update the justification (Good Cause) statement to reflect your current need to have a CCW permit. **Criteria:** As such, each Sheriff and Police Chief is authorized to establish such good cause based upon the facts specific to his or her jurisdictional needs, per the court decision.

Examples of valid reasons to request a license include, but are not limited to:

- Victims of a violent crime and/or documented threats of violence.
- Business owners who carry large sums of cash or valuable items.
- Business owners who work all hours in remote areas and are likely to encounter dangerous people and situations.

Examples of invalid reasons to request a license include, but are not limited to:

- Recreation in remote areas
- Hunting and Fishing
- Self-protection and protection family (without credible threats of violence).
- Employment in the security field, i.e. security guard, body guard, VIP protection.
- Personal safety due to job conditions or duties placed on the applicant by their employer
